The institutions shall ensure the fulfillment of the following :-

The institutions shall maintain the teaching staff strength of 1+5 for the proposed (a) ETT Course.

The institutions shall adhere to all the other regulations and guidelines as framed (b) by NCTE from time to time.

The institutions shall within one month of the receipt of the Recognition order, (c) convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated along with an authorized official of the Regional Committee.

That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the (d) form of FDR in favour of the managements / institutions.
